Participants entering into the Leadership Belleville program make a 9-month time commitment in order to be eligible to graduate.

- Kick-off Breakfast August 18, 2017. Attendance is strongly encouraged.
- Two-Day Retreat September 14-15, 2017 at Pere Marquette Lodge in Grafton Attendance at the retreat is mandatory. Any participant who does not attend the retreat cannot continue with the program.
- Seven full-day sessions once a month: October 20, 2017, November 17, 2017, December 8, 2017, January 29, 2018, February 16, 2018, March 16, 2018, April 20, 2018 Any participant missing more than <u>16</u> hours throughout the program (October-April) will not meet the qualifications to graduate.
- Reflection Day, May 4, 2018 Attendance is mandatory. Any participant who does not attend Reflection Day and participate in the presentations will not meet the qualifications to graduate.
- Graduation Banquet, May 4, 2018 Attendance is strongly encouraged.

V. TUITION
