IV. GRADUATION REQUIREMENTS

Participants entering into the Leadership Belleville program make a 9-month time commitment in order to be eligible to graduate.

- Kick-off Breakfast - August 17, 2018. Attendance is strongly encouraged.
- Two-Day Retreat - September 13 & 14, 2018 at Todd Hall Retreat Center in Columbia, IL - **Attendance at the retreat is mandatory. Any participant who does not attend the retreat cannot continue with the program.**
- Seven full-day sessions once a month: October 19, 2018, November 16, 2018, December 14, 2018, January 18, 2019, February 15, 2019, March 15, 2019, April 19, 2019 - **Any participant missing more than 16 hours throughout the program (October-April) will not meet the qualifications to graduate.**
- Reflection Day, May 3, 2019 – **Attendance is mandatory. Any participant who does not attend Reflection Day and participate in the presentations will not meet the qualifications to graduate.**
- Graduation Banquet, May 3, 2019 – Attendance is strongly encouraged.

V. TUITION

Tuition for each participant accepted into Leadership Belleville is **\$1,100** for members of the Greater Belleville Chamber of Commerce. The price for non-members is **\$1,500**. The participant, the participant's employer or a sponsoring organization, may pay tuition. Tuition is to be submitted upon notice of acceptance into the program and payable prior to August 10, 2018.
